1. About This Qualification

The **iPET Network Level 3 Diploma in Professional Dog Grooming (Exclusive to Pets at Home)** is designed to provide the most in-depth training, available on the market, for colleagues working at Pets at Home in Pets Grooming salons. It is aimed at Candidates who wish to gain extensive skills and knowledge in dog grooming, enabling them to prepare, style and finish a range of dog breeds using both commercial and traditional styling techniques. It will guide an understanding of health and safety requirements within a dog grooming salon, awareness of canine behaviour and how this can be utilised in a salon environment, canine emergency first aid skills, and an understanding of the basic running of Pets Grooming salon.

Leading industry experts have developed and reviewed this qualification in collaboration to ensure the outcome is relevant to the dog grooming industry, meets the needs of Pets at Home Colleagues and supports the continued growth and development of the sector.

The qualification forms an excellent balance of theoretical and practical learning ensuring that vocational skills lead the qualification while being fully supported by underpinning knowledge throughout.

Objectives of the qualification

This qualification aims to take Candidates on a journey from complete beginners to competent and confident professional dog groomers. Depending on the needs of the individual Candidate, the qualification can:

- Prepare individuals to progress to a qualification in the same subject area but at a higher level or requiring more specific knowledge, skills and understanding
- Support their role in the workplace
- Encourage engagement in learning

iPET Network have designed this qualification to enable Candidates to:

- Recognise health and safety legislation and company policies relevant to Pets Grooming salon environment and work safely, both with people and dogs
- Ensure the customer journey is supported within Pets Grooming
- Understand how to recognise signs of canine health and ill-health and respond appropriately to first aid emergency scenarios
- Show awareness of canine behaviour and communication and how to apply this knowledge to dogs being groomed
- Prepare, plan, style and finish a range of commercial, breed standard and advanced scissor dog grooming styles
- Recognise the normal anatomy of the dog's skin, hair and nails
- Adapt the grooming process to ensure that welfare needs of the individual dogs are always maintained

- Understand the basic requirements of running a Pets Grooming salon

Suggested progression following completion of the qualification:

- iPET Network Level 4 Higher Professional Diploma in Dog Grooming
- iPET Network Level 3 Award in Hand Stripping
- iPET Network Level 4 Award in Canine Emergency First Aid in the Workplace
- iPET Network Level 3 Award for Educators in the Canine and Feline Sector

It is a requirement that assessment of this qualification is conducted in English.

The iPET Network Level 3 Diploma in Professional Dog Grooming (Exclusive to Pets at Home) is regulated by Ofqual.

Who is involved?

Candidates will be assigned a **Tutor** (a Grooming Development Expertise Trainer, GDET), who will be responsible for delivery of training, marking and assessing written and practical work and monitoring progression. The Tutor is responsible for supporting Candidate e-portfolio completion.

Within the salon, on a daily basis, training and mentoring will be provided by a combination of experienced Stylists, Salon Manager and Senior Salon Trainers (**Trainers**). Whilst these Colleagues input to training, they do not have access to the e-portfolio and do not assess Candidates' work.

Guided Learning Hours (GLH)

Guided Learning Hours (GLH) are defined by the [Apprenticeships, Skills, Children and Learning Act, 2009](#) as the number of hours the Candidate spends:

- Being taught or given instruction by a lecturer, tutor, supervisor or other appropriate provider of education or training, or
- Otherwise participating in education or training under the immediate guidance or supervision of such a person.

GLH does not include time spent on unsupervised preparation or study, whether at home or otherwise.

iPET Network has calculated the GLH for this qualification representing an estimate of the amount of actual guided learning which could reasonably be expected to be required to achieve the standard required to obtain the qualification.

Estimated GLH will be stated for each unit which should be used by Training Providers as a guide for devising teaching and learning plans. GLH may be recorded within the e-portfolio (if being used) or within the Candidate Hours Log (if the e-portfolio is not used).

Total Qualification Time (TQT)

Total qualification time is defined as the number of Guided Learning Hours (GLH) **plus** the time taken by the Candidate for independent, unsupervised study. Individual Learners' requirements and individual teaching styles mean there will be variation in the actual time taken to complete a qualification. Values for Total Qualification Time are estimates as some Candidates will be able to achieve units and qualifications within a shorter time than indicated. Others, for example those with additional support requirements, may need longer.

Guided Learning Hours and Total Qualification Time for this qualification are:

iPET Network Level 3 Diploma in Professional Dog Grooming (Exclusive to Pets at Home)

GLH (Guided Learning Hours): 807 hours

TQT (Total Qualification Time): 1200 hours

Qualification Delivery Requirements

Due to the practical nature of this qualification, the **Formal Summative Assessments must take place face-to-face, in person or remotely via live Zoom/Teams.**

The remainder of the qualification may be delivered as the Training Provider sees fit, ensuring that Guided Learning Hours requirements are met. As part of the application to deliver, Training Providers must be able to evidence how they intend to deliver the qualification, including the methods by which they will achieve the estimated GLH and TQT.

The expected duration of this qualification is 18 months, within which, Candidates will spend a total of 70 weeks working 7.5 hours per day on either a full-time or part-time basis. Within this time, Candidates should expect to receive 10 hours per week of Trainer/Tutor supported guided learning. Approximately 1 hour per week should be spent working on independent study such as reading, research or preparing written work for assessments.

Candidates completing the Fast-Track route, are expected to complete the qualification within 9 months. Prior experience and learning will be acknowledged and will enable the Candidate to complete the full qualification within a reduced timeframe.

2. Candidate Requirements

Entry requirements

Candidates need to have a level of understanding to be able to work at Level 3 but do not need to hold a Level 2 qualification in Dog Grooming. Candidates must be a Pets Grooming Colleague to be eligible for registration. There are no other entry requirements.

Minimum age

The minimum age for access to this qualification is 16 years.

Tutors ought to satisfy themselves that Candidates have a level of maturity appropriate for units included in the qualifications that they offer. If in doubt, please contact iPET Network for advice.

Eligibility for Fast Track

The iPET Network Level 3 Diploma in Professional Dog Grooming (Exclusive to Pet at Home) can be offered as a 'Fast Track' option. This delivery route takes into consideration the Candidate's prior attainment and experience. The Candidate must be able to demonstrate the following to prove eligibility for the Fast Track option of delivery:

- 1 years' experience of styling; or
- 1 year of working in a Pets Grooming salon and completed an internal programme of training, or
- A regulated Level 2 Dog Grooming qualification plus 1 years' experience or,
- A regulated Level 3 Certificate/Diploma in Dog Grooming qualification

Eligibility must be evidenced via a CV, certificates and/or internal Pets at Home training records.

Reasonable Adjustment and Special Considerations

Candidates need to have the physical ability to complete the practical training and assessment of the qualification. The assessment methodology is appropriate and rigorous for individuals or groups of Candidates.

If Tutors have Candidates with identified learning needs, please refer to the Reasonable Adjustment and Special Considerations Policy, available from iPET Network. This gives clear guidance on the reasonable adjustments and arrangements that take account of disability or learning difficulty without compromising the achievement of the assessment criteria.

When carrying out any assessment method, Tutors will need to consider the presentation of the assessment task to the Candidate to make it fair and accessible. Tutors may also need to consider arrangements for Candidates with particular learning difficulties and will need to be aware of iPET Network's policy on reasonable adjustments.

Assessment methods may be adapted in accordance with specific requirements, however, this may be decided and authorised by iPET Network only.

Further guidance and support can be accessed at iPET Network.

3. Recognition of Prior Learning (RPL)

Exemption (also known as 'Recognition of Prior Certificated Learning) - is the facility for a Candidate to claim exemption from some of the achievement requirements of an iPET Network qualification using certificated evidence, for example certificated NQF achievement. This must be of an equivalent or higher value to an iPET Network unit but may not share the exact assessment criteria or learning aims.

Training Providers wishing to obtain further details regarding awarding of RPL should refer to the iPET Network ***Recognition of Prior Learning Policy***.

4. Induction / Initial Assessment

An initial assessment / induction for each Candidate must be made before the start of their programme to identify:

- If the Candidate has any specific learning or training needs
- The support and guidance they may need when working towards their qualification
- The Candidate's suitability for the type and level of qualification

Tutors/Trainers must carry out an induction so that Candidates fully understand the requirements of the qualification, their responsibilities as a Candidate, and the responsibilities of the Tutor and Pets at Home. This information will need to be recorded e.g. within a contract.

During the induction, Candidates must be made aware of academic malpractice and the consequences of committing malpractice such as plagiarism or cheating. Please see iPET Network's Malpractice and Maladministration Policy and Procedure (including sanctions) for details of indicative sanctions against Candidates.

5. Achieving the Qualification

Credits

To be awarded the iPET Network Level 3 Diploma in Professional Dog Grooming (Exclusive to Pets at Home) Candidates must achieve 120 credits.

Unit achievement

All of the assessment criteria in a unit must be met before the unit is deemed to be achieved. The unit achievement is not graded: units are either achieved or not achieved.

Recording achievement

Tutors must record the Candidate's achievement of each unit on an appropriate form(s) or electronic system. Tutors should record the Candidate's achievement against the specific unit assessment criteria evidenced by the task.

Authentication of the Candidate's work

Tutors must demonstrate that the Candidate's work is authentic. This can be done through using iPET Network's e-portfolio system which provides secure access to each Candidate.

Assessments must demonstrate authenticity - please refer to assessment methods in this Qualification Handbook.

If malpractice is suspected, the candidate will be reported following the Tutor and iPET Network's Malpractice and Maladministration policies.

Duration of registration

All Candidates will be registered with iPET Network for a period of 36 months. Failure of the Candidate to complete the qualification during this timeframe will incur an additional charge for re-registration. Please refer to your **Terms and Conditions** for further details. Extension to registration may be obtained with written permission under specific extenuating circumstances. Please contact iPET Network for advice regarding extensions to registration.

7. Assessment

This qualification requires achievement of the specified units and summative assessments. The assessment process is as follows:

- Assessments are internally arranged and carried out by iPET Network approved Tutors at the Training Provider (Pets at Home).

- The resulting portfolios of assessed evidence are internally quality assured by an Internal Quality Assurer (IQA) at Pets at Home or by remote visit (all formal assessments must be sampled from every Candidate).
- The portfolios of assessed evidence are quality assured by an iPET Network External Quality Assurer (EQA). Please note that all Tutors will require an IQA direct observation per year.
- The portfolios of assessed evidence are quality assured by an iPET Network External Quality Assurer (EQA). Please note a minimum of one Candidate's formal assessment will be sampled during the EQA audit.

Specimen Assessment Materials

Specimen assessment materials are not available for this qualification.

Marking

These assessments are pass or fail and the Assessor's decision is final. The use of artificial intelligence to mark any candidate's work is strictly prohibited.

*Please note re-assessments are permitted.

Appeals

To ensure a fair assessment procedure is carried out, the Candidate must be fully briefed on the assessment requirements and given instructions on their right to appeal. All Training Providers must have an up to date Appeals procedure.

What constitutes a fail?

It is at the Tutor's professional discretion if they pass or fail the Candidate. The criteria for what constitutes a fail is different according to the assessment being undertaken. Below is a guide to what might constitute a fail during the 4 Summative Formal Assessments:

- Inappropriate handling of the dog
- Injury to the dog
- Safety of the dog compromised
- Personal safety jeopardy
- Poor quality of the preparation work
- Preparation work not completed to client requirements
- Unacceptable level of customer service

Summative Formal Assessment 2 (Tidy Trim)

- Inappropriate handling of the dog
- Injury to the dog
- Safety of the dog compromised
- Personal safety jeopardy
- Poor quality of the groom
- Unsafe use of equipment
- Groom not completed to client requirements

Summative Formal Assessment 3 (Commercial Basic Style)

- Inappropriate handling of the dog
- Injury to the dog
- Safety of the dog compromised
- Personal safety jeopardy
- Poor quality of the groom
- Unsafe use of equipment
- Groom not completed to client requirements

Summative Formal Assessment 4 (Advanced Scissor Style)

- Inappropriate handling of the dog
- Injury to the dog
- Safety of the dog compromised
- Personal safety jeopardy
- Poor quality of the groom
- Unsafe use of equipment
- Groom not completed to client requirements

* Please note these lists are not exhaustive.

When making an assessment decision it is important that all evidence and feedback is documented to support the assessment decision whether it is a pass or fail. If the decision is a fail, then the Candidate must be provided with support and the opportunity to re-sit the assessment once they are ready.

8. Offering the Qualification

Pets at Home, in delivering this qualification, will need to demonstrate the ability to adhere to quality assurance and assessment regulations.

All procedures for the use of this qualification or units of this qualification, including approval, registration of Candidates, quality assurance process and certification will be completed through iPET Network, who will have an allocated Account Manager to support Pets at Home Colleagues. Any queries or difficulties should be directed to the iPET Network office on 0800 433 4700.

Approval to offer the qualification

The requirements stipulated to deliver the qualification, as stated in Appendix A of this guide, must be complied with, prior to approval.

Standardisation

Standardisation is a process that promotes consistency in the understanding and application of standards.



Standardisation:

- Establishes statements on the standard of evidence required to meet the assessment criteria for the units in iPET Network qualifications;
- Makes recommendations on assessment practice;
- Produces advice and guidance for the assessment of units;
- Identifies good practice in assessment.

It is a requirement of the Training Provider approval process that Pets at Home must provide assessment materials and Candidates' evidence for standardisation if requested.

iPET Network will notify Pets at Home of the required sample for standardisation purposes. Assessment materials, Candidates' evidence and Tutor feedback will be sent to iPET Network by Pets at Home.

Outcomes from standardisation will be available to Training Providers through iPET Network.

Support for Training Providers

iPET Network provides all Training Providers with on-going support and advice on the use of iPET Network units and qualifications, including the requirements for assessment.

If Training Providers who are approved to offer iPET Network units and qualifications have obtained a UKPRN (UK Provider Reference Number) from the UKRLP (UK Register of Learning Providers), this will be used as the Training Provider's reference number. If a Training Provider has not obtained a UKPRN they will be issued with a unique iPET Network Training Provider number.

Information about obtaining a Unique Learner Number (ULN) on behalf of the Candidates is included in the *iPET Network Training Provider Manual*.

Training Provider responsibilities

Pets at Home should identify a named contact person who will be responsible for any iPET Network provision within the organisation.

The Pets at Home contact person must ensure all procedures relating to the delivery of the qualification operate effectively in the centre.

The Pets at Home contact is the person responsible for confirming and ensuring that Pets at Home meets all the iPET Network requirements for Training Provider recognition.

The Pets at Home contact is responsible for ensuring all relevant iPET Network documentation is distributed as required within the organisation and that the security requirements for external assessment are adhered to, where applicable.

9. Requirements to Deliver This Qualification

To offer this qualification, Pets at Home must ensure that Tutors delivering this qualification have one of the following recognised professional qualifications:

- The iPET Network Level 3 Diploma in Professional Dog Grooming (Exclusive to Pets at Home); or
- the iPET Network Level 3 Diploma in Dog Grooming and Salon Management

Or,

- the OCNWM Level 3 Diploma in Dog Grooming; or
- the full City and Guilds Diploma 7763-03; or
- the new City and Guilds 7863-03 Diploma

And be working towards the iPET Network Level 3 Diploma in Professional Dog Grooming (Exclusive to Pets at Home) (to be achieved within 12 months).

And, hold a teaching certificate (examples detailed below) and / or are able to demonstrate their teaching experience:

- Level 3 Award in Education and Training; or
- iPET Network Level 3 Award for Educators in the Canine and Feline Sector; or
- Level 4 Certificate in Education and Training; or
- Level 3 or 4 PTLLS (or equivalent).

If no formal teaching qualification is held, it will be a requirement that a teaching qualification is achieved within 12 months of approval.

And,

- Has a minimum of 3 years' professional and practical dog grooming experience.

NB, Pets at Home must have an appointed Canine Emergency First Aid practitioner and must be able to provide a copy of certification. Pets at Home must ensure that the Tutor's certification is updated every 3 years.

Pets at Home must also ensure that they have in place an Internal Quality Assurer who:

- Holds or is working towards a Level 4 Award in Internal Quality Assurance of Assessment Processes and Practices or its equivalent
- Has substantial experience of working in or assessing qualifications in dog grooming; and
- Is familiar with the assessment requirements of the qualification for which they are the Internal Quality Assurer

Or

- Gold package registrations are used (*refer to Training Provider fees*)
